ELIGIBILITY CRITERIA CONTINUED

- Ineligible Applicants/Activities: i) Real Estate Industry;
ii) Retail/Wholesale;
iii) Services of a Personal or Social Nature;
iv) Government Services; Government Departments & Agencies;
v) Consultants seeking assessment of own services;
vi) Those with mandates deemed not suitable for government funding;

HIGHLIGHTS

CAS PROCESS


- Client meets a Metro Business Opportunities Development Officer and receives a CAS Application Form.
- Client identifies/works with a Consultant and receives a Consultant Proposal.
- Client submits the CAS Application Form and Consultant Proposal to a Development Officer.
- Consultant is approved and a Contract is issued (to be signed/returned within 10 business days).
- Client submits copies of Consultant Final Report, Invoice and Client Evaluation Form.
- Development Officer forwards 75% payment (to a maximum of \$5,000) to the Consultant.
